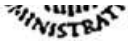

We plan to increase EMILY G. KETSCHEK's monthly **Supplemental Security Income (SSI)** payment from \$183.17 to \$305.67 beginning July 2017. The amount will change because her other income decreased. She will continue to get the new amount each month unless there is a change in the information we use to figure her payment.

We explain how we figured the monthly payment amount on the worksheet(s) at the end of this letter. The explanation shows how her income, other than any SSI payments, affects her SSI payment.
